**B2** What are the reasons for the Decision?

At the launch of the ARG(O) scheme, allowing for the allocation of £250,000 to Staffordshire County Council (SCC) and a further £100,000 towards the Council's Additional Restrictions Grant for Business Springboard Boost, unspent funds totalled £735,515.37. This included £205,823.37 specifically ring fenced to businesses severely impacted by coronavirus restrictions and the rise of the Omicron variant and must not fund wider business support measures.

However, SCC has returned £155,000 of the £250,000 allocation paid to them thus increasing the available monies to support businesses.

When the scheme was opened, emails were issued to 336 businesses who had submitted an Expression of Interest form and/or received a previous grant payment since the inception of Business Support Grants in March 2020.

As at 10 March 2022, the Council had received 179 applications, allowing for duplicates and resubmissions. 135 applications had been assessed of which 73 (55%) were successful with a further 62 (45%) rejected. The remaining 34 applications are being assessed and it is assumed no more than 20 of those cases will be approved for payment.

The current ARG(O) payment is a fixed rate of £2,000 irrespective as to whether the applicant is assessed for Business Rates or not and the RV of the property occupied. To date, £146,000 in grant payments have been made which leaves unspent funds totalling £744,515.37

Under the existing payment limit of £2,000 per successful application, the Council is likely to pay out a further £50,000 to £60,000 dependent upon the number of applications received before the closure date of 18 March and those finally approved. This will result in an underspend of approximately £685,000 which would have to be returned to the Government.

#### Recommendations:

The current qualifying criteria will remain the same as detailed within EDR 397.22 [Additional Restrictions Grant (Omicron) scheme January

2022], together with the currently defined business sectors and types to be supported save for one minor change relating to travel agents.

All other conditions within the scheme remain the same, including, though not limited to, the following:

Refusal of requests to make multiple payments to a single bank account

Closing date for applications not later than 18 March 2022

The final date of determination and payment of 31 March 2022

Other than the payment of supplementary funds, no applicant will receive more than one ARG payment

On request by the applicant, the Shared Service Centre Manager/ Revenues Team Leader will review refused applications and their decision will be final. Aggrieved applicants may apply for a Judicial Review.

In recognition of the impact of the Omicron variant upon the travel industry per paragraph 28 of the Additional Restrictions Grant Guidance for Local Authorities issued by BEIS on 20 January 2022, independent travel agents may be included within the ARG(O) scheme. Inclusion is subject to the proviso the business is located within ESBC and operates from one premises only. Where the business operates outside ESBC and/or trades from more than one property, it will be ineligible to receive funds under this scheme. The amount paid will be as detailed below.

Businesses, having received funding under the Omicron Hospitality and Leisure Grant scheme (OHLG), will receive a supplement of 50% paid via the ARG(O) scheme. The supplementary payment increases the payment per successful applicant as shown in the following table.

As at 10 March, OHLG payment had been paid to 156 applicants. Where the OHLG payment is

supplemented in accordance with the above table, the additional amount paid via the ARG(O) scheme is detailed below and totals £259,966.

In respect of ARG(O) applicants who have received payments, the amount paid is to be increased from the flat rate of £2,000 to that suggested for the OHLG supplemented rate and within the RV bands provided. Where a business is not liable to pay Business Rates, the amount paid is equal to the payment made to businesses in the lowest RV band of the revised supplemented rates for the OHLG scheme. In this regard, the extra supplementary payments which could be made are detailed below,

All the supplementary payments total £420,966 and reduces the unspent ARG funding to £323,549.37

At 10 March 2022, there were 24 OHLG and 34 ARG(O) applications awaiting assessment. Assuming the enhanced rates are applied, it is estimated up to 35 applicants will be successful and the value of the payments may total approximately £180,000. Should this occur, £143,549.37 will remain unspent which may support another 30 businesses dependent upon the RV of the property for which a successful claim is made.

Where necessary, the rate of payments may be reviewed and increased to reduce the amount needing repayment to the Government in respect of unpaid funds. The review should take place no later than 28 March 2022.

# **B5** What are the financial implications?

The Additional Restrictions Grant scheme is fully funded by the Government under Section 31 of the Local Government Finance Act 2003. 229 businesses have been supported date and should the supplementary payments made, approximately 65 other businesses may be funded.

Funds were received in August 2021 totalling £894,692 of which £250,000 was paid to Staffordshire County Council though £155,000 has been returned. A further £15,000 was paid to two businesses under criteria adopted under the terms of the last ARG review conducted July 2021. The nett funds from August then totalled £784,692 of which £100,000.00 was allocated to the Additional Restrictions Grant for Business Springboard Boost thus reducing the available monies for the ARG (Omicron) scheme to £684,692.00. This sum has been supplemented by additional funding provided in January 2022 totalling £205,823.37.

The sum available to support the current ARG scheme totalled £890,515.37 of which £146,000.00 has been paid to date leaving a residual sum of £744,515.37 to be allocated as outlines in Section B2 above.

Any unspent monies must be returned to BEIS following the closure of the scheme.
