Councillors noted the report which stated that: out of 132 corporate targets, 118 were green, 3 were amber, 5 were red with 3 not yet due to be reported and 2 had been deleted; of the 126 live targets, 93.65% were green status, 2.38% were amber status and 3.97% were red status; at the end of Quarter 3 of the Leisure Contract Performance, 77 performance indicators were green whilst 1 performance indicator was amber; project progress on the Towns Fund Programme including key risks, current financial profiles , and total spend for three projects; Specialist College Project (£3,494,864), Cycle Network Enhancements (£1,063,788.19 and the Canal Towpath Project (£157,821.28)
