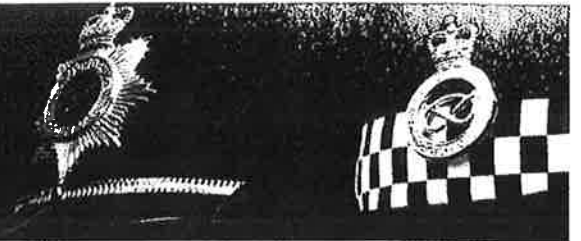

**Locomotive, 28 Station Street, Burton, Staffs, DE14 1AU**  
**Temporary Event Notice – 24<sup>th</sup> February 2018**

I refer to the above application, a copy of which has been served on the Chief Officer of Staffordshire Police, the purpose of this letter is to notify East Staffordshire Borough Council that the application is opposed by Staffordshire Police.

It is the Police's position that the granting of this licence would undermine the Licensing Objectives, namely the prevention of Crime and Disorder, Public Safety and Public Nuisance.

We cannot support a temporary event notice due to the premises already having had Police intervention in relation to incident levels. The premises in December saw a spike in incidents, some of them during the times that a temporary event notice was in place, also a

number of which are of a violent nature, therefore by extending their hours for this date will, we feel, will further contribute to the venues incident levels.
