Application to vary a Premises Licence to specify an individual as Designated Premises Supervisor - Parmjit Kaur.

OBJECTION NOTICE

In relation to the above application received by Staffordshire Police on the 18th July 2022, Staffordshire Police wish to submit relevant representations.

Staffordshire Police are satisfied that the exceptional circumstances of the case are such that granting the application would undermine the prevention of crime and disorder licensing objective.

The current applicant, Parmjit Kaur, is the owner and Premises Licence Holder of the Locomotive Sports Bar and has previously held the position of Designated Premises Supervisor of the premises. Over an extended period of time there have been a large number of incidents of disorder linked to the premises, breaches of the conditions in the operating schedule of the Premises Licence and other matters such as non-duty paid goods being found on the premises.

The Premises Licence has twice been reviewed by the Licensing Sub-committee on application by Staffordshire Police and on each occasion the decision of the committee members has been to revoke it, the first occasion being when Parmjit Kaur was the Designated Premises Supervisor. The Locomotive Sports Bar is currently operating under a revoked Premises Licence pending an appeal to be heard at Magistrate's Court.

The viewpoint of the Police is that the appointment of Parmjit Kaur to the position of Designated Premises Supervisor would seriously undermine the licensing objective of the prevention of crime and disorder. It is the stance of Staffordshire Police that whilst holding the position of Premises Licence Holder, Parmjit Kaur has in effect had the day to day control of the premises and been ineffective at upholding the licensing objectives and this situation would continue if she was to take on the added responsibility of Designated Premises Supervisor.



These objections may be amplified before the hearing of this application by service of additional evidence and/or by oral submissions at the hearing itself.

In light of this Staffordshire Police respectfully request that the Licensing Sub-Committee consider this representation in respect of this application.
